Benefits can be applied for for students up to the age of 25 if they attend a general or vocational school and do not receive a training allowance.

The same applies to children who attend a daycare center. The term "daycare facility" includes both kindergartens and all other forms of childcare provided by childminders or similar institutions.

The benefits for participation in social and cultural life (point E) can only be provided for children and Young people who are not yet of legal age (under 18 years of age) are provided.

Please indicate for whom the benefits are being requested. Several can use the application Services are claimed. A separate application must be submitted for each person.

## School/daycare center excursions

With the approval, the costs for all one-day trips to the school/daycare center are covered until the end of the approval period.
