## Services for education and participation Community lunch

### General information

Expenses incurred by students, children in daycare centers or in daycare are recognized for participation in a communal lunch.

The prerequisite for covering the expenses is that the lunch meal is eaten together. For students, it is also necessary that the meal is offered under the school's responsibility or is agreed upon through a cooperation agreement between the school and the day care facility.

The services are paid directly to the lunch provider.
